### *What's the Difference?*

As we move forward in our careers, it has become evident that the Security Professional is becoming a vital link in Business Resumption and Emergency Planning. In order to better provide a quality product, we must understand the differences in the common nomenclature used by our business counterparts. Here are two common management tools that often get confused: Risk Analysis and Business Impact Analysis.

Risk Analysis (RA) is a management tool. The standards used to measure the risk function are determined by whatever perimeters management decides as vital to maintain business operations. There are four considerations when determining the perimeters of Risk Analysis: 1) Identify the Assets that need to be protected. 2) Identify the kinds of risks that may affect the assets. 3) Determine the probability of risk occurrence. 4) Determine the impact or effect in dollar values.

Business Impact Analysis (BIA) is also a management tool. It is used to determine what functions are critical to continue operation of the organization. It is used to identify what areas are interdependent upon each other which would rely on the other for business continuity. It also presents a financial basis by which management can determine the most cost-effective recovery strategies. The BIA will allow management to understand how best to allocate resources in the event of a business impact.

The objectives of the two analyses are similar but differ in the depth that each probes. In the Risk Analysis, it looks for an overall risk impact that may affect the function of an operation. It is much broader in scope. It will list every possible hazard that could halt production. In a Business Impact Analysis, it is more site specific. It actually determines what business

functions are necessary to maintain business continuity. It provides management with the specific tool necessary to lessen the impact of an event and speed up the resumption of normal business operations.

The goal of the two functions overlaps, that is to keep the operations moving forward. The goal of a Risk Analysis is to determine the rank of criticality of risks, while the BIA is tasked with identifying the impacts of the loss of business functions over time and to help identify interdependent areas of business, and to prioritize the order of functions to recover.

A risk analysis is a solitary experience, while a business impact analysis is a top-down partnership with senior management. A BIA is the actual nuts and bolts plan that will be implemented to recover from an impact event.

The ease of application does vary between the two areas. For a Risk Analysis, the application will entail a broad scope overview of a hazard that could impact an operation. While a Business Impact Analysis will directly address the plan on returning to normal business operations. Both are extensive in their own rights, but I think the BIA is a much more detailed plan of resumption and harder to apply. The Risk Analysis is a broad concept while the Business Impact Analysis is the application of resources to recover from an impact.

Both functions are vital to identify and prepare for an impact to an operation. Both serve to identify the process of recovery. The RA shows the big picture while the BIA gives the detail on how the operation will recover from that impact. They are each dependant upon the other to optimize the resumption time of an operation post impact.

Both of our previous scholarship recipients -- David Justice and John Hewitt -- went on to earn their CPP designations shortly after having attended this course.
